

All candidates to note that detail of marks secured and response sheet etc. would be available on RRC website on completion of selection process.
2. In case the DV for all the candidates is not completed on the scheduled date i.e 27/03/2024, DV for the remaining candidates can also be conducted on the very next day.
3. Merely calling a candidate for scouting skill assessment does not in any way entitled him/her to an appointment in the Railways. The candidature of all the mentioned candidates is purely provisional and subject to verification/correctness of the information submitted at various stages of selection process and fulfilling the eligibility criteria in all respects.

5. Every care has been taken in preparing the above result by RRC Delhi and RRC right is reserved to rectify any inadvertent error/typographical mistake/printing mistake.


